Customer may use restroom facilities if they are located in a customer area. Customers may not enter the food preparation area, food storage area, or the utensils washing /storage areas in order to access the restrooms. All food, utensils and equipment must be protected from contamination.

Routine Inspection: The DPH-EH conducts routine inspections of all food facilities in Los Angeles County. Following the issuance of your Public Health Permit by the Plan Check Program, an Environmental Health Specialist from your local district will conduct an inspection of your facility. If your Business is located in a city that has adopted the grading ordinance, the inspector will post a grade or score card at your facility. Grade / Score cards are not issued by the Plan Check Program.

CORRECTIVE ACTION: 1) PROVIDE / INDICATE THE MOP SINK THAT WILL SERVICE THIS FOOD OPERATION . THE MOP MUST BE WITH A 100 FEET DISTANCE FROM THE COFFEE BAR VIA PATH OF TRAVEL . MOP SINK MUST HAVE THE FOLLOWING INSTALLED : CHEMICAL SHELF , VACUUM BREAKER AT MOP SINK FAUCET , AND BROOM RACK .

CALIFORNIA RETAIL FOOD CODE: *A room, area, or cabinet separated from any food preparation or storage area, or warewashing or storage area shall be provided for the storage of cleaning equipment and supplies. After use, mops shall be placed in a position that allows them to air-dry without soiling walls, equipment, or supplies. At least one curbed cleaning facility or janitorial sink equipped with hot and cold water and a drain shall be provided and conveniently located for the cleaning of mops or similar wet floor cleaning tools and for the disposal of mop water and similar liquid waste. CORRECTIVE ACTION: 1) INDICATE THE LOCATION OF THE DRY FOOD STORAGE FOR THIS FOOD OPERATION . THE AREA / ROOM MUST HAVE APPROVED FINISHES AND LIGHTING .

CALIFORNIA RETAIL FOOD CODE: *Adequate and suitable space shall be provided for the storage of food. Food shall be protected from contamination by storing the food in a clean, dry location, where it is not exposed to splash, dust, vermin, or other forms of contamination or adulteration, and at least six inches above the floor. THIS FOOD FACILITY MUST HAVE " FIXED " NON OPERABLE GLASS WINDOWS (FRONT AND BOTH SIDES . THE OPERABLE WINDOW CAN BE THE SERVICE WINDOW (216 SQ . INCHES OR 432 SQ IN WITH AIR CURTAIN .

CALIFORNIA RETAIL FOOD CODE: A food facility shall at all times be constructed, equipped, maintained, and operated as to prevent the entrance and harborage of animals, birds, and vermin, including, but not limited to, rodents and insects.
